Boat Storage (does not include hauling/launching labor)

Outside Mast-In

Storage Price = (LOA x beam) x \$7.50/SF

*Storage Cost + \$1000 fixed price for both haul & launch

**Outside Mast-In storage depends on LOA, rig height & draft. Sails must be removed to store mast-in.

Dinghy Storage

Up to 12 feet	\$190 per season + labor
12 - 16 feet	\$300 per season + labor

Outboard Storage

Up to 40 hp	\$110 per season + labor

Environmental Surcharge Assessed at 2% of materials

Consumables Material Surcharge Assessed at 4% of labor

- 1) A 50% storage deposit is required with signed storage agreement.
- 2) Owners may pay their storage and service fees with a credit card; however, a 3% convenience fee will be applied on payments over \$5,000.
- 3) "No Cash, No Splash" All bills must be paid before the boat leaves the yard.
- 4) Invoices will be mailed monthly and are due upon receipt. A service charge of 1.5% per month (18% annually) will be added to balances 30 days past due.
- 5) Owners may perform work on their boats while they are stored outside. However, the yard's shop equipment & tools will not be available for personal use. No work may be performed on boats/equipment while they are located inside a Lyman-Morse building. Any debris left around the yard will be cleaned up at the boat owner's expense.
- 6) No work may be performed by outside contractors or other paid workers unless previously arranged. All contractors must provide a certificate of insurance and comply with Lyman-Morse's subcontractor requirements. Contractors & paid workers must register at the office before performing any work. We reserve the right to assess a subcontractor fee.
- 7) In order to comply with environmental regulations, all bottom sanding and scraping must be performed in conjunction with an approved collection system. Waste must be disposed of properly.
- 8) All vehicles must be parked with keys available to the yard and are left at the owner's risk.
- 9) Rates are subject to change without notice.
- 10) Winter storage is September 30 to May 15. Shorter periods will not be pro-rated.
- 11) Lyman-Morse reserves the right to assess a surcharge for fuel and utilities if costs rise above our anticipated costs
